Closter Dock Road Drainage Improvements Project – He still has not received written comments from the county thus unfortunately the project will likely have to be put off until next year. NJDEP permits obtained five years ago expire at month's end and they will have to reapply. He had requested an extension but as no work has commenced NJDEP advised that process is not applicable nor does it fall under the Permit Extension Act. He will follow-up with the State and also with the County to have them include the additional fees that will be required with the reimbursement to the Borough.
