WHEREAS, N.J.S.A. 40A:5-4 requires the governing body of every local unit to have made an annual audit of its books, accounts and financial transactions, and

WHEREAS, the Annual Report of Audit for the year 2012 has been filed by a Registered Municipal Accountant with the Municipal Clerk pursuant to N.J.S.A. 40A:5-6, and a copy has been received by each member of the governing body, and

WHEREAS, R.S. 52:27BB-34 authorizes the Local Finance Board of the State of New Jersey to prescribe reports pertaining to the local fiscal affairs, and

WHEREAS, the Local Finance Board has promulgated N.J.A.C. 5:30-6.5, a regulation requiring that the governing body of each municipality shall by resolution certify to the Local Finance Board of the State of New Jersey that all members of the governing body have reviewed, as a minimum, the sections of the annual audit entitled: General Comments and Recommendations; and

WHEREAS, the members of the governing body have personally reviewed as a minimum the Annual Report of Audit, and specifically the sections of the Annual Audit entitled: 'General Comments – Recommendations' as evidenced by the group affidavit form of the governing body attached hereto, and

WHEREAS, such resolution of certification shall be adopted by the Governing Body no later than forty-five days after the receipt of the annual audit, pursuant to N.J.A.C. 5:30-6.5; and

WHEREAS, all members of the governing body have received and have familiarized themselves with, at least, the minimum requirements of the Local Finance Board of the State of New Jersey, as stated aforesaid and have subscribed to the affidavit, as provided by the Local Finance Board, and

WHEREAS, failure to comply with the regulations of the Local Finance Board of the State of New Jersey may subject the members of the local governing body to the penalty provisions of <u>R.S.</u> 52:27BB-52 - to wit:

<u>R.S.</u> 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the director (Director of Local Government Services), under the provision of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than one thousand dollars (\$1,000.00) or imprisoned for not more than one year, or both, in addition shall forfeit his office."

NOW, THEREFORE BE IT RESOLVED, That the Mayor and Council of the Borough of Alpine, hereby states that it has complied with <u>N.J.A.C.</u> 5:30-6.5 and does hereby submit a certified copy of this resolution and the required affidavit to said Board to show evidence of said compliance.

BOROUGH OF ALPINE
ORDINANCE NO. 736

AN ORDINANCE OF THE BOROUGH OF ALPINE TO AMEND CHAPTER 220, SECTION 13 AUTHORIZING AN AMENDMENT TO THE ZONING CODE FOR AN ADDITION OF A NEW SECTION ENTITLED "ELECTRIC POWER GENERATOR SYSTEMS".

WHEREAS, due to the increasing frequency of weather related power outages, it has come to the attention of the Mayor and Council of the Borough of Alpine that power generators have become an increasingly necessary amenity desired by its residents;

WHEREAS, such structures can be noisy and detract from the aesthetics of bucolic settings such as exist within the Borough of Alpine unless regulated for noise and situated appropriately;

NOW THEREFORE, BE IT ORDAINED that the Mayor and Council of the Borough of Alpine find that amendment to the Zoning Code of the Borough of Alpine will be enhanced by the addition of the following new section:

Section 220-13B(5).

Electric generators, which are to be used during public utility electrical outages, shall be permitted in a side or rear yard, subject to the measured sound pressure levels of Section 153-3 (Noise Ordinance). No portion of an electric generator shall be located within a "buffer area" as defined by Section 205-1.B, and in no case shall an electric generator be located any closer to a lot line or public right-of-way than ten (10) feet. All such equipment shall be suitably buffered and screened to minimize views from adjacent properties and the public right-of-way.

BE IT FURTHER ORDAINED, that all Ordinances or parts of Ordinances that are inconsistent with the provisions of this Ordinance are hereby repealed, but only to the extent of such inconsistencies; and

BE IT FURTHER ORDAINED, that the provisions of this Ordinance are severable. If any part of this Ordinance is declared to be unconstitutional or invalid by any Court, the remaining parts of this Ordinance will remain in full force and effect; and

BE IT ORDAINED that this Ordinance shall take effect upon passage and publication as required by law and further upon the filing of a copy of the Ordinance with the Bergen County Planning Board in accordance with N.J.S.A. 40:55D-16; and

BE IT FURTHER ORDAINED that this Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.
