- Alpine has been awarded a NJDOT Grant for the fourth year in a row. The 2021 award is for the purpose of resurfacing of Marie Major Drive \$153,469.00. The Municipal Aide is funded by the increase in gasoline taxes enacted under former Governor Christie.
- Bond Anticipation (short term) Note renewed at an interest cost \$22,259 less than last year.
  Principal also reduced. We are making progress at reducing debt.

### B) Governing Body Acknowledgment of Best Practices Inventory

The best practices inventory was certified and submitted on November 4, 2020 prior to the November 5 deadline. At the time of submission there was an inventory score of 24 affirmative out of 29 questions.
