### **PUBLIC COMMENTS**

**George Stafford**, 16 Kitchell Avenue, Wharton, NJ appeared representing the NJ Highlands Coalition and Keep It Green, a statewide advocacy group for open space to ask the governing body to pass a resolution for legislative support to create a sustainable program for the preservation of open space, particularly farm and forested areas. Following last year's severe drought reservoirs bounced back but recharge of groundwater and small streams is taking longer posing a critical problem. NJ loses an estimated 25% of treated water through leaks. Infrastructure repairs will be costly. Since 1996 NJ has lost 250,000 acres of open space while adding a million people. To help municipalities that set aside open space they propose payments in lieu of taxes that would taper down over 2-3 years permitting budget adjustments over time versus a larger gap the first year.

Mr. Stafford next highlighted General Election Ballot Question #2 to amend the NJ Constitution dedicating moneys obtained from pollution fines and damages. Recent cases demonstrate although offenders remit fines and penalties to the State, cleanup can't proceed because funds were reallocated to balance other areas of the State budget. Question #2 would prohibit that practice and dedicate such funds solely to the intended cleanup.

Councilman Halbreich questioned how other states address these issues. Mr. Stafford was not sure noting geography and needs vary from State to State and explained New Jersey is densely populated with two main watershed areas, the Passaic and Raritan and there are two kinds of "water law" dependent on whether you live east or west of the Mississippi River.

### BOROUGH OF ALPINE ORDINANCE NO. 772

### "AN ORDINANCE TO AMEND: CHAPTER 179 ENTITLED "SITE PLAN REVIEW" & TO AMEND CHAPTER 185 ENTITLED "SOIL FILL AND SOIL REMOVAL"

BE IT ORDAINED, by the Mayor and Council of the Borough of Alpine, in the County of Bergen that "The Revised General Ordinances of the Borough of Alpine, 1970" be revised by the AMENDMENT OF Chapter 179 entitled "Site Plan Review"; as follows:

Section 1. Amend Chapter 179-4(D) to read as follows:

D. Completion and inspection of improvements. The installation of improvements as required in § 179-6 and as included in the site plan including principal and accessory buildings or other structures shall not commence until after the approval of the final site plan and the submission of a certified location survey (including proposed elevations) to the Construction Official/Building Inspector. Such installation shall be subject to inspection by the Borough Engineer, and approval shall be revoked if there is significant deviation from the site plan as approved. Performance and maintenance bonds shall be released subject to approval by the Borough Engineer and Borough Council. All improvements shall be completed in a timely manner so as not to leave the site in an unfinished or unsightly condition, as determined by the Borough Council, and if this is not done, the final approval shall be deemed to be revoked, and the performance and maintenance bonds may be used by the Borough to restore the site to an acceptable condition. The issuance of building and occupancy permits shall be conditioned on the completion of improvements as specified in the final site plan application and submission and approval of an as-built certified survey.

BE IT FURTHER ORDAINED, by the Mayor and Council of the Borough of Alpine, in the County of Bergen that "The Revised General Ordinances of the Borough of Alpine, 1970" be revised by the AMENDMENT OF Chapter 185 entitled "Soil Fill and Soil Fill Removal"; as follows:

<u>Section 2.</u> Amend Chapter 185-4(G) to add a new (3), renumbering the current (3) and (4) to (4) and (5) with the new (3) to read as follows:

(3) Location Survey

Prior to the commencement of installation or construction of any building or structure in the area which was the subject of an application for soil movement permit, the owner shall submit a certified location stakeout to the Construction Official/Building Inspector to verify that the proposed building or improvement is in the proper location and elevation.

Section 3. Amend Chapter 185-7 to add a new (D) to read as follows:

D. The Borough Council and/or Planning Board and/or the Board of Adjustment, in its discretion, may require that, as a condition of any revised approval to allow the offending condition to remain, the violator take such steps to reduce the impact of the violation upon neighboring properties including, but not limited to, the planting of landscaping or installation of drainage. In addition, such agency may impose an assessment, not to exceed \$15,000.00 which shall be paid to the Borough of Alpine. Should the imposition of any such fee be reversed or otherwise set aside by a court of competent jurisdiction, the revised approval shall be null and void and the offending condition shall be eliminated by restoration of the original conditions as described in Section B above.

<u>Section 4.</u> Should any section, paragraph, sentence, clause or phrase of this Chapter be declared unconstitutional or invalid for any reason, the remaining portions thereof shall not be affect thereby and shall remain in full force and effect, and to this and the provisions of this Chapter are hereby declared to be severable.

<u>Section 5.</u> This Chapter shall take effect immediately upon adoption and publication as provided by law.
