- 2. ALL DOG AND CAT LICENSES EXPIRE ON JANUARY 31 OF EACH YEAR AND MUST BE RENEWED DURING THE MONTH OF JANUARY.
- 3. ALL DOGS AND CATS MUST BE LICENSED EVEN IF YOUR PET NEVER LEAVES THE HOUSE.
- 4. CHECK RABIES AND NEUTER STATUS. IF THIS IS A NEW REGISTRATION OR THERE HAVE BEEN ANY CHANGES SINCE THE LAST REGISTRATION, BE SURE TO ENCLOSE REQUIRED VETERINARIAN CERTIFICATES WHICH WILL BE RETURNED. PETS WHOSE RABIES VACCINATIONS HAVE BEEN ALLOWED TO EXPIRE MAY BE SUBJECT TO A FINE IN ADDITION TO LICENSING & LATE FEES.
- 5. RABIES VACCINATION EXPIRATION DATE MUST BE LATER THAN NOVEMBER 1 OF THE YEAR FOR WHICH THE LICENSE IS BEING ISSUED. IF THE DATE ON YOUR PET'S CERTIFICATE IS EARLIER, THEY MUST GET A BOOSTER AND NEW VACCINATION CERTIFICATE.
- 6. IF YOUR VET CITES A MEDICAL REASON WHY YOUR PET CAN NOT GET A RABIES VACCINE YOU AND YOUR VET MUST COMPLETE AND SUBMIT FORM VPH-28 (AVAILABLE FROM OUR OFFICE) AND UPDATE THIS EVERY YEAR
- 7. DOGS ARE NOT PERMITTED TO RUN AT LARGE, DISTURB THE PEACE WITH PROLONGED BARKING OR ALLOWED TO SOIL, DEFECATE OR COMMIT ANY NUISANCE ON PUBLIC PROPERTY OR ANY PRIVATE PROPERTY THAT YOU DO NOT OWN. OWNERS THAT PERMIT SUCH OFFENSES MAY BE SUBJECT TO A FINE.
